



AMENDMENT 3
To State Term Contract 92121500-14-01
Security Officer Services, Armed and Unarmed

This Amendment 3 ("Amendment"), effective as of December 16, 2019, to the Security Officer Services, Armed and Unarmed 92121500-14-01 ("Contract") between the State of Florida, Department of Management Services ("Department"), and Universal Protection Services, LLC d/b/a Allied Universal Security Services. ("Contractor"). Department and Contractor are collectively referred to herein as the "Parties."

WHEREAS the Contract was entered into by the Parties on December 15, 2014, to continue through December 15, 2016, for the provision of Security Officer Services, Armed and Unarmed, pursuant to Solicitation No; RFP 05-92121500-J; and

WHEREAS Amendment 1, effective December 9, 2016, AlliedBarton Security Services assigned all of its rights and obligations under the contract to Universal Protection Services, LLC d/b/a Allied Universal Security Services

WHEREAS Amendment 2, effective December 9, 2016, renewed the Contract for three years, and updated and added language to the Contract; and

WHEREAS the Parties agreed that the Contract may be amended by mutual agreement as provided in Contract Exhibit A: Contract Conditions, section 4.42, Modification of Terms; and

WHEREAS in accordance with Subsection 287.057(12), Florida Statutes, upon mutual agreement, the Department and the Contractor may extend the Contract.

NOW THEREFORE, in consideration of the mutual covenants contained herein, the Parties agree the Contract shall be amended as follows:

- 1.0 Contract Extension.** The term of this Contract shall be extended for a period of six (6) months, effective December 16, 2019 through June 15, 2020, unless extended, cancelled, or terminated as provided in the Contract terms and conditions.
- 2.0 Contract Modification.** Section 8 is hereby added as a term to the Contract

8 Scrutinized Companies - Termination by the Department.

The Department may, at its option, terminate the Contract if the Contractor is found to have submitted a false certification as provided under section 287.135(5), F.S., or been placed on

the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or been engaged in business operations in Cuba or Syria, or to have been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

Warrant of Authority. Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

3.0 Effect. This Amendment is hereby made a part of this Contract. Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. This Amendment sets forth the entire understanding between the Parties with regard to the subject matter hereof.
