This Second Amendment to Project Agreement No. 23-003-SC (“Second Amendment”) dated December 29, 2022, between the City of Sunrise, a municipal corporation (“City”) and Stantec Consulting Services, Inc. (“Consultant”).

WHEREAS, on May 7, 2021, the City of Sunrise and Stantec Consulting Services, Inc. entered into a Continuing Services Agreement for professional services – Water, Wastewater, Wastewater Reuse and Natural Gas Utilities Projects; and

WHEREAS, on December 29, 2022 the City of Sunrise and Stantec Consulting Services, Inc. entered into a Project Agreement No. 23-003-SC (“Project Agreement”) for professional engineering services for the Lift Stations 128 and 210, as authorized under the Project Agreement; and

WHEREAS, on October 29, 2025 the City of Sunrise and Stantec Consulting Services, Inc. entered into a First Amendment to a Project Agreement No. 23-003-SC to revise scope of work and increase cost of the construction management services.

WHEREAS, on December 8, 2025 the City Manager, through written notification, exercised the one hundred and eighty (180) day extension and extended the term to June 26, 2026.

WHEREAS, the parties wish to amend the Project Agreement to extend the term by 365 days, through June 26, 2027

NOW THEREFORE, in consideration of the mutual covenants and obligations created hereby, as well as other good and valuable considerations, the parties agree as follows:

1. Recitals Incorporated. The foregoing recitals are incorporated by reference and made part of this Amendment.
2. Amendment to Contract. The Project Agreement is hereby amended by adding the words in underscore and striking the words in ~~strikethrough~~.

- 7.1 This Agreement shall commence on the date this instrument is fully executed by all parties and shall continue in full force and effect ~~for 1,095 days~~ through June 26,

2027, unless otherwise terminated pursuant to Section 8.1 or 8.2, or other applicable sections of this Agreement. ~~The City's City Manager, in his sole discretion, may extend the term of this Project Agreement through written notification to the Consultant. Such extension shall not exceed one hundred eighty (180) days.~~ No further extensions of this Agreement shall be effective unless authorized by City code or City Commission action.

6. Effective Date. This Second Amendment shall be effective when it is fully executed by both parties.
