This First Amendment to Project Agreement No. 24-001-BC ("First Amendment") dated November 22, 2023, between the City of Sunrise, a municipal corporation (hereinafter referred to as "City") and Brown and Caldwell (Corporation) (Consultant").

WHEREAS, on May 7, 2021, the City of Sunrise and Brown and Caldwell (Corporation) entered into a Continuing Services Agreement for professional services – Water, Wastewater, Wastewater Reuse and Natural Gas Utilities Projects; and

WHEREAS, on November 22, 2023, the City of Sunrise and Brown and Caldwell (Corporation) entered into a Project Agreement No. 24-001-BC ("Project Agreement") for professional engineering services for the Lift Station 127 Basin Improvements, as authorized under the Project Agreement; and

WHEREAS, on November 24, 2025 the City Manager, through written notification, exercised the one hundred and eighty (180) day extension and extended the term to July 11, 2026

WHEREAS, the parties wish to amend the Project Agreement to extend the term by 365 days, through July 11, 2027

NOW THEREFORE, in consideration of the mutual covenants and obligations created hereby, as well as other good and valuable considerations, the parties agree as follows:

1. Recitals Incorporated. The foregoing recitals are incorporated by reference and made part of this Amendment.
2. Amendment to Contract. The Project Agreement is hereby amended by adding the words in underscore and striking the words in ~~strikethrough~~.
 - a. Section 7.1 This Agreement shall commence on the date this instrument is fully executed by all parties and shall continue in full force and effect ~~for 782 days~~ through July 11, 2027, unless otherwise terminated pursuant to Section 8.1 or 8.2, or other applicable sections of this Agreement. ~~The City's City Manager, in his sole discretion, may extend the term of this Project Agreement through written notification to the Consultant. Such extension shall not exceed one-~~

~~hundred eighty (180) days.~~ No further extensions of this Agreement shall be effective unless authorized by City code or City Commission action.

5. Effective Date. This First Amendment shall be effective when it is fully executed by both parties.
