A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING THE PURCHASE OF LIQUID CARBON DIOXIDE FROM AIRGAS USA, LLC UNDER THE TERMS OF THE CITY OF POMPANO BEACH SOLICITATION ITB26-036 CARBON DIOXIDE LIQUID BULK DELIVERY, AS THE LEAD AGENCY FOR THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING COOPERATIVE GROUP; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, after competitive procurement, the City of Pompano Beach, as the lead agency for the Southeast Florida Governmental Purchasing Cooperative Group, awarded solicitation ITB26-036 Carbon Dioxide Liquid Bulk Delivery to Airgas USA, LLC, effective June 23, 2026; and

WHEREAS, the City of Sunrise Utilities Department desires to purchase liquid carbon dioxide supplies and services on an as-needed basis under the terms of the City of Pompano Beach Solicitation ITB26-036.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The purchase of liquid carbon dioxide from Airgas USA, LLC under the terms of the City of Pompano Beach solicitation ITB26-036 Carbon Dioxide Liquid Bulk Delivery, as the lead agency for the Southeast Florida Governmental Purchasing Cooperative Group, is hereby approved. A copy of the Contract Award is attached hereto and made a part of this Resolution as Exhibit A.

Section 2. Because these purchases will be made using an existing governmental contract, the City's formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 3. The Procurement Manager is hereby authorized to issue a Purchase Order and to take all necessary action for the full performance of this award.

Section 4. The Procurement Manager or designee is hereby authorized to renew, amend or extend the award when renewed, amended or extended by the lead agency.

Section 5. Effective Date. This Resolution shall be effective immediately upon its passage.
