A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING AND ADOPTING THE “SECOND PROGRAM YEAR ACTION PLAN FY 2026-2027 ANNUAL ACTION PLAN” UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM; APPROVING THE CITY’S APPLICATION FOR FEDERAL ASSISTANCE UNDER THE FY 2026-2027 ANNUAL ACTION PLAN; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Sunrise is an entitlement recipient of federal funds from the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) Program; and

WHEREAS, on July 8, 2025, via Resolution No. 21-58-25-A, the City Commission adopted the 2025-2029 Consolidated Plan; and

WHEREAS, the City anticipates receiving \$693,472 in Fiscal Year 2026 CDBG funds to address Community Development and housing needs; and

WHEREAS, the City anticipates receiving \$185,459 in Fiscal Year 2026 HOME funds to address Community Development and housing needs; and

WHEREAS, consistent with the FY 2025-2029 Consolidated Plan, the City must adopt a FY 2026-2027 Annual Action Plan, detailing the specific activities to be provided by the City to receive funding.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The above-referenced Whereas clauses are hereby incorporated as the legislative intent of this Resolution.

Section 2. Approval and Adoption of the Plan. The City’s “Second Program Year Action Plan FY 2026-2027 Annual Action Plan” (FY 2026-2027 Annual Action Plan) under the Community Development Block Grant (CDBG) Program is hereby approved and adopted. A copy of the FY 2026-2027 Annual Action plan is attached hereto and made a part of this Resolution as Exhibit A.

Section 3. Approval of Application. The City’s Application for Federal Assistance under the FY 2026-2027 Annual Action Plan is hereby approved.

Section 4. Execution of Application. The City Manager is hereby authorized to execute the Application for Federal Assistance SF-424, the Applicant and Recipient Assurances and Certifications, the Assurances – Construction Programs, the Certifications, the Specific Community Development Block Grant Certifications, the Optional Community Development Block Grant Certification, the Specific HOME Certifications, and the Appendix to Certifications, all of which are attached hereto and made a part of this Resolution as Exhibit B.

Section 5. Funding Approval/Agreement. The City Manager is further authorized to execute all documents related to the Application for Federal Assistance, including the Funding Approval/Agreement form, upon review and approval by the City Attorney, and all documents related to regulatory compliance and federal cross-cutting requirements. The City Manager shall provide a copy of the Funding Approval/Agreement to the City Clerk.

Section 6. Effective Date. This Resolution shall be effective immediately upon its passage.
