**A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING
“PIGGYBACK AGREEMENT NO. PB 26-14-05-MF BETWEEN THE CITY
OF SUNRISE AND H2 ENVIRO SOLUTIONS LLC D/B/A H2SOLUTIONS”
FOR INDUSTRIAL MAINTENANCE AND REPAIR SERVICES UTILIZING
MANATEE COUNTY, FLORIDA, AGREEMENT NO. 25-R086189ED; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, after competitive procurement, Manatee County, Florida, awarded Agreement No. 25-R086189ED for industrial maintenance and repair services to H2 Enviro Solutions LLC d/b/a H2sOolutions; and

WHEREAS, the City of Sunrise desires to purchase industrial maintenance and repair services on an as-needed basis under the terms of Manatee County Agreement No. 25-R086189ED, as amended.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The foregoing recitals are hereby ratified and incorporated as the legislative intent of this Resolution.

Section 2. “Piggyback Agreement No. 26-14-05-MF between the City of Sunrise and H2 Enviro Solutions LLC d/b/a H2sOolutions” (Agreement) under the terms of Manatee County, Florida, Agreement No. 25-R086189ED is hereby approved. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 3. Because these purchases will be made using an existing governmental contract, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 4. The Procurement Manager is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 5. The Procurement Manager or designee is hereby authorized to renew, amend, or extend the Agreement when renewed, amended, or extended by the lead agency.

Section 6. Effective Date. This Resolution shall be effective immediately upon its passage.
