A Child Is Missing, Inc. understands and agrees that this documentation must occur on or about the end of each fiscal year, September, and will be submitted to the Chief of Police or his designee on our organization's letterhead and will simply acknowledge receipt of LETf funds and that they have been expended in accordance with Florida State Statute 932.7055.
