**A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING
“PIGGYBACK AGREEMENT NO. 26-16-07-ES BETWEEN THE CITY OF
SUNRISE AND BOUND TREE MEDICAL, LLC” FOR THE PURCHASE
OF EMS SUPPLIES UTILIZING OKALOOSA COUNTY, FLORIDA,
CONTRACT NO. C26-4259-PS; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of Sunrise Police and Fire Departments require continuous access to emergency medical services (EMS) pharmaceuticals, medical supplies, airway equipment, trauma supplies, and other mission-critical materials necessary to support daily emergency medical operations; and

WHEREAS, after competitive procurement, Okaloosa County, Florida, awarded Contract No. C26-4259-PS for the purchase of EMS supplies to Bound Tree Medical, LLC, effective June 16, 2026; and

WHEREAS, the City of Sunrise desires to purchase EMS supplies on an as-needed basis under the terms of the Okaloosa County Contract No. C26-4259-PS.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The foregoing recitals are hereby ratified and incorporated as the legislative intent of this Resolution.

Section 2. “Piggyback Agreement No. 26-16-07-ES between the City of Sunrise and Bound Tree Medical, LLC” (Agreement) is hereby approved in an amount not to exceed the FY 2025-2026 approved budgeted funds, with subsequent years’ expenditures subject to budget approval. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 3. Because these purchases will be made using an existing governmental contract, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 4. The Procurement Manager is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 5. The Procurement Manager or designee is hereby authorized to renew, amend, or extend the Agreement when renewed, amended, or extended by the lead agency.

Section 6. Effective Date. This Resolution shall be effective immediately upon its passage.
