**A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING “COOPERATIVE AGREEMENT NO. 26-24-06-MM BETWEEN THE CITY OF SUNRISE AND HERITAGE POOL SUPPLY GROUP, INC. D/B/A COMMERCIAL ENERGY SPECIALISTS” UNDER THE TERMS OF SOURCEWELL MASTER AGREEMENT NO. 012226-AQUA FOR POOL CHEMICALS AND EQUIPMENT WITH RELATED SERVICES; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Leisure Services Department requires pool and spa chemicals for aquatic facilities throughout the City; and

WHEREAS, after competitive procurement, Sourcewell, a State of Minnesota local government unit and purchasing cooperative, awarded Contract No. 012226-Aqua for Pool Chemicals and Equipment with Related Services to Commercial Energy Specialists LLC an Aquafinity Company n/k/a Heritage Pool Supply Group, Inc. d/b/a Commercial Energy Specialists, effective February 23, 2026; and

WHEREAS, the City of Sunrise desires to purchase pool and spa chemicals under the terms of Sourcewell Contract No. 012226-Aqua.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The foregoing recitals are hereby ratified and incorporated as the legislative intent of this Resolution.

Section 2. “Cooperative Agreement No. 26-24-06-MM between the City of Sunrise and Heritage Pool Supply Group, Inc. d/b/a Commercial Energy Specialists” (Agreement) is hereby approved in an amount not to exceed the FY 2025-2026 approved budgeted funds, with subsequent years’ expenditures subject to budget approval. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 3. Because these purchases will be made using an existing governmental contract, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the City of Sunrise Florida.

Section 4. The Procurement Manager or designee is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 5. The Procurement Manager or designee is hereby authorized to renew, amend or extend this award when renewed, amended or extended by the lead agency.

Section 6. Effective Date. This Resolution shall be effective immediately upon its passage.
