**A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING
“STANDARD CONTRACT NO. C-26-04-08-ES BETWEEN THE CITY OF
SUNRISE, FLORIDA AND ACCENTURE INFRASTRUCTURE AND
CAPITAL PROJECTS, LLC” FOR FINANCIAL SERVICES FOR A FIRE
RESCUE ASSESSMENT PROGRAM UPDATE; AND PROVIDING AN
EFFECTIVE DATE.**

WHEREAS, City of Sunrise Ordinance 829-X authorizes the imposition of Fire Rescue assessments for fire suppression and prevention services, facilities, and programs within the City of Sunrise; and

WHEREAS, the last update to the Fire Rescue Assessment was completed in June 2013. Since that time, the City has experienced growth in both residential and commercial properties, along with changes in expenditures, calls for services, staffing levels, apparatus and other items used in the calculation of the assessment; and

WHEREAS, Accenture Infrastructure and Capital Projects, LLC (Accenture), formerly known as Government Services Group, Inc. (GSG), prepared the prior report used in the 2013 Fire Rescue Assessment; and

WHEREAS, the Sunrise Fire Rescue Department requires financial advisory services to assist in the preparation of a report and workplan to identify the full cost of fire prevention and suppression services to determine preliminary revenue requirements to support such services, to update the apportionment methodology, and to calculate preliminary schedules of rates; and

WHEREAS, Accenture provided the City a scope of work for such services, which City staff has reviewed and finds fair and reasonable.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. “Standard Contract No. C-26-04-08-ES between the City of Sunrise, Florida and Accenture Infrastructure and Capital Projects, LLC” (Contract) for a Fire Rescue Assessment Program update is hereby approved. A copy of the Contract is attached hereto and made part of this Resolution as Exhibit A. The Procurement Manager is authorized to execute the Contract.

Section 2. Pursuant to Section 5-173(c)(6) of the Code of the City of Sunrise, Florida, the City's formal bidding procedures are waived for financial services.

Section 3. City staff is hereby authorized to take all action necessary to perform the Contract.

Section 4. Effective Date. This Resolution shall be effective immediately upon its passage.
