**A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING AN “INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND CITY OF SUNRISE TO FUND THE DESIGN OF A REGIONAL BIOSOLIDS SOLUTIONS FACILITY”; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, in 2022, Broward County Water and Wastewater Services initiated a working group with eleven (11) utilities including Sunrise, Broward County, Cooper City, Coral Springs Improvement District, Plantation, Pembroke Pines, Fort Lauderdale, Davie, Hollywood, Margate, and Miramar to explore regional solutions for a more cost effective, local, and centralized approach to treating the biosolids from various Wastewater Treatment Plants; and

WHEREAS, in 2023, the City of Sunrise Commission approved an Interlocal Agreement (ILA) with Broward County for a Regional Biosolids Solutions Study. The study recommended a regional facility using thermal drying technology that produces Class AA Biosolids to be constructed within the Broward County Water and Wastewater site; and

WHEREAS, the parties wish to enter a new Interlocal Agreement to jointly fund the design of the regional facility.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. An “Interlocal Agreement between Broward County and City of Sunrise to Fund the Design of a Regional Biosolids Solutions Facility” (ILA) is hereby approved. A copy of the ILA is attached hereto and made a part of this Resolution as Exhibit A.

Section 2. The Mayor is hereby authorized to execute the ILA.

Section 3. City staff are hereby authorized to take all actions necessary to fully perform the City’s responsibilities under the ILA.

Section 4. Effective Date. This Resolution shall be effective immediately upon its passage.
