**SPRINGTREE WATER TREATMENT PLANT FILTER REHABILITATION DESIGN, PERMITTING,
AND BIDDING SERVICES**

This Second Amendment to Project Agreement No. 22-010-CE dated May 24, 2022, between the City of Sunrise, a municipal corporation (City) and Carollo Engineers, Inc. (Consultant).

WHEREAS, Project Agreement No. 22-010-CE (Project Agreement) was approved by Resolution No. 21-45-22-C and entered into between the City of Sunrise and Carollo Engineers, Inc. for professional engineering services for the Springtree Water Treatment Plant Filter Rehabilitation Design, Permitting, and Bidding Services as authorized under the Project Agreement; and

WHEREAS, on April 18, 2024, the City Manager provided a one hundred eighty (180) days extension to the Project Agreement until October 20, 2024 in accordance with Paragraph 7.1; and

WHEREAS, on October 8, 2024 the City Commission amended the Project Agreement and extended the term to October 1, 2025 via the First Amendment which was approved by Resolution No. 21-45-24-G; and

WHEREAS, the Project Agreement expires on October 1, 2025 and the parties wish to extend the term of the Project Agreement to allow for time for bidding services.

NOW THEREFORE, in consideration of the mutual covenants and obligations created hereby, as well as other good and valuable considerations, the parties agree as follows:

1. Recitals Incorporated. The foregoing recitals are incorporated by reference and made part of this Amendment.
2. Amendment to Project Agreement. The Project Agreement is amended to add words shown in underscore and to delete words shown in ~~strikethrough~~:
 - A. Section 7.1 of the Project Agreement is hereby amended as follows:

7.1 This Agreement shall commence on the date this instrument is fully executed by all parties and shall continue in full force and effect for ~~1226~~ 1406 days, unless otherwise terminated pursuant to Section 8.1 or 8.2, or other applicable sections of this Agreement. No further extensions of this Agreement shall be effective unless authorized by City code or City Commission action.

5. Effective Date. This Second Amendment shall be effective when it is fully executed by both parties.


