RESOLUTION NO. 19-107-21-A

A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, EXPRESSING THE CITY'S SUPPORT FOR THE OAKLAND PARK BOULEVARD COMPLETE STREETS PROJECT FROM THE HIATUS ROAD GREENWAY TO NORTH UNIVERSITY DRIVE AS PART OF THE BROWARD COUNTY METROPOLITAN PLANNING ORGANIZATION'S (MPO) COMPLETE STREETS MASTER PLAN PER LOCAL AGENCY PROGRAM (LAP) AGREEMENT; COMMITTING TO FUND THE CONSTRUCTION CONTINGENCY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Broward Metropolitan Planning Organization (MPO) approved the Broward Complete Streets Master Plan on February 14th, 2019; and

WHEREAS, the Oakland Park Boulevard Complete Streets Project from the Hiatus Road Greenway to North University Drive has been identified as a high-ranking project in the Complete Streets Master Plan's list of recommendations; and

WHEREAS, the City Commission approved Resolution No. 19-107 providing support for the aforementioned project to be included in the final 2045 Metropolitan Transportation Plan, committing to work with the Broward MPO, transportation partners, and the public to prepare the project for programming in the Broward MPO's Transportation Improvement Program; and

WHEREAS, a resolution from the Sunrise City Commission stating support for the project is required to establish funding eligibility; and

WHEREAS, federally funded projects off the state highway system are delivered using the federally mandated Local Agency Program (LAP) process; and

WHEREAS, the City of Sunrise will administer and deliver the project under LAP when the project is deemed eligible for funding; and

WHEREAS, the LAP program is reimbursement based as specified in the LAP agreement; and

WHEREAS, the City of Sunrise commits to funding upfront costs for design, Construction Engineering and Inspection (CEI), and construction to be then reimbursed per the requirements of LAP before the project is programmed for funding; and

WHEREAS, the City of Sunrise commits to program funding for construction contingency per the requirements of LAP; and

WHEREAS, Oakland Park Boulevard Complete Streets Project from the Hiatus Road Greenway to North University Drive will be constructed within the City of Sunrise, Broward County and South Florida Water Management District right of way; and

WHEREAS, it is the responsibility of the City of Sunrise to maintain or coordinate the maintenance of the roadways and improvements within the City of Sunrise and South Florida Water Management District right of way after the project's completion; and

WHEREAS, it is the responsibility of Broward County to maintain or coordinate the maintenance of the roadways and improvements within Broward County right of way after the project's completion.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The foregoing Whereas clauses are hereby ratified and confirmed as the legislative intent of this Resolution.

Section 2. The City of Sunrise hereby expresses its support for the Oakland Park Boulevard Complete Streets Project from the Hiatus Road Greenway to North University Drive.

Section 3. Effective Date. This Resolution shall be effective immediately upon its passage.


