RESOLUTION NO. _____

A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, UPDATING RESOLUTION NO. 11-183, AS AMENDED, WHICH IDENTIFIES CHARITABLE ORGANIZATIONS, NONPROFIT ENTITIES, FUNDRAISING EVENTS, AND CITY EVENTS THAT ARE FORMALLY APPROVED BY THE CITY OF SUNRISE FOR PURPOSES OF CHARITABLE SOLICITATIONS UNDER THE COUNTY’S ELECTED OFFICIAL CODE OF ETHICS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, effective January 2, 2012, the Broward County Board of County Commissioners enacted Ordinance No. 2011-19 which was codified as Section 1-19 of the County’s Code and which created ethics standards for County Commissioners, elected municipal officials, and certain other specified individuals; and

WHEREAS, Section 1-19 of the County’s Code contains certain requirements that apply to an elected official who solicits funds, goods, or services on behalf of charitable organizations, nonprofit entities, or individuals in need; and

WHEREAS, the City Commission’s Resolution No. 11-183, as amended, identifies those charitable organizations, nonprofit entities, fundraising events and City events that are formally approved by the City; and

WHEREAS, the City Commission of the City of Sunrise updates Resolution No. 11-183 periodically and adds or removes charitable organizations, nonprofit entities, fundraising events, and City events.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The above stated Whereas clauses are hereby adopted as true and incorporated herein.

Section 2. Resolution No. 11-183, as amended, is hereby further amended and ratified, and the City Commission hereby determines that charitable solicitations for the charitable organizations, nonprofit entities, fundraising events, and City events listed on the amended Exhibit A are formally approved by the City of Sunrise for purposes of the County’s Elected Official Code of Ethics. Formal approval allows charitable solicitations under Section 1-19(c)(5)a.5 of the Broward County Code provided the charitable solicitation is permissible under all applicable federal laws, state laws, City Codes, and County Codes.

Section 3. Exhibit A may be amended by Resolution or Motion and is not the sole method to determine the City's formal approval of a charitable organization, nonprofit entity, fundraising event, or City event.

Section 4. Effective Date. This Resolution shall be effective immediately upon its passage.
