A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING “COOPERATIVE AGREEMENT NO. 26-19-03-HR BETWEEN THE CITY OF SUNRISE AND ACORDIS INTERNATIONAL CORP.” UNDER THE TERMS OF THE STATE OF UTAH COOPERATIVE CONTRACT NO. AR3227 AND THE STATE OF FLORIDA NASPO VALUEPOINT PARTICIPATING ADDENDUM NO. 43220000-NASPO-19-ACS FOR DATA COMMUNICATIONS PRODUCTS AND SERVICES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, after competitive procurement, the State of Utah, on behalf of NASPO ValuePoint, a cooperative purchasing program, awarded Contract No. AR3227 to Cisco Systems, Inc. for Data Communications Products and Services (Master Agreement); and

WHEREAS, the State of Florida, Department of Management Services, utilizing the Master Agreement, entered into NASPO ValuePoint Participating Addendum No. 43220000-NASPO-19-ACS with Cisco Systems, Inc. (Florida Addendum). Acordis International Corp. is an authorized dealer under the Florida Addendum; and

WHEREAS, the City of Sunrise Information Technology Department desires to purchase equipment and services for a turn-key high-speed Wi-Fi solution at the Sunrise Amphitheater and across the municipal campus from Acordis International Corp. utilizing the Master Agreement and the Florida Addendum.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. “Cooperative Agreement No. 26-19-03-HR between the City of Sunrise and Acordis International Corp.” (Agreement) under the terms of the State of Utah Contract No. AR3227 and the State of Florida NASPO ValuePoint Participating Addendum 43220000-NASPO-19-ACS for Data Communications Products and Services is hereby approved. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 2. Because these purchases will be made using existing governmental contracts, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 3. The Procurement Manager is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 4. The Procurement Manager or designee is hereby authorized to renew, amend or extend the Agreement when renewed, amended or extended by the lead agency.

Section 5. Effective Date. This Resolution shall be effective immediately upon its passage.
