A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING “COOPERATIVE AGREEMENT NO. 26-17-02-LV BETWEEN THE CITY OF SUNRISE AND JOHNSON CONTROLS FIRE PROTECTION LP, JOHNSON CONTROLS, INC., AND JOHNSON CONTROLS SECURITY SOLUTIONS, LLC” UNDER THE TERMS OF SOURCEWELL MASTER AGREEMENT NO. 121024-JHN FOR FACILITY SECURITY SYSTEMS, EQUIPMENT, AND SOFTWARE WITH RELATED SERVICES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, after competitive procurement, Sourcewell, a Minnesota local government and service cooperative, awarded Master Agreement No. 121024-JHN for Facility Security Systems, Equipment, and Software with Related Services to Johnson Controls Fire Protection LP, Johnson Controls, Inc., and Johnson Controls Security Solutions, LLC, effective May 11, 2025 through February 18, 2029; and

WHEREAS, the City of Sunrise desires to purchase intrusion detection systems, programming software, access control cards, and related accessories, as well as installation, maintenance, and repair services on an as-needed basis under the terms of the Sourcewell Master Agreement.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. “Cooperative Agreement No. 26-17-02-LV between the City of Sunrise and Johnson Controls Fire Protection LP, Johnson Controls, Inc., and Johnson Controls Security Solutions, LLC” (Agreement) under the terms of Sourcewell Master Agreement No. 121024-JHN is hereby approved. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 2. Because these purchases will be made using an existing governmental contract, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 3. The Procurement Manager is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 4. The Procurement Manager or designee is hereby authorized to renew, amend or extend the Agreement when renewed, amended or extended by the lead agency.

Section 5. Effective Date. This Resolution shall be effective immediately upon its passage.
