A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING “COOPERATIVE AGREEMENT NO. 26-20-03-HR BETWEEN THE CITY OF SUNRISE AND ONECBI, LLC.” UNDER THE TERMS OF NEW YORK STATE CONTRACT NO. 23295 AND STATE OF FLORIDA ALTERNATE CONTRACT SOURCE NO. 56120000-24-NY-ACS FOR FURNITURE, ALL TYPES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, after competitive procurement, New York State awarded Contract No. 23295 for Furniture, All Types (Master Agreement) to various contractors including Global Industries, Inc. and MillerKnoll, Inc.; and

WHEREAS, the State of Florida, Department of Management Services, utilizing the Master Agreement, entered into Alternate Contract Source No. 56120000-24-NY-ACS (ACS Contract) with Global Industries, Inc. and MillerKnoll, Inc. OneCBI, LLC is an authorized dealer under the ACS Contract; and

WHEREAS, the City of Sunrise Utilities Department desires to purchase furniture from OneCBI, LLC utilizing the Master Agreement and the ACS Contract.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. “Cooperative Agreement No. 26-20-03-HR between the City of Sunrise and OneCBI, LLC.” (Agreement) under the terms of New York State Contract No. 23295 and State of Florida Alternate Contract Source No. 56120000-24-NY-ACS for Furniture, All Types, is hereby approved. A copy of the Agreement is attached hereto and made a part of this Resolution as Exhibit A.

Section 2. Because these purchases will be made using existing governmental contracts, the City’s formal bidding procedures are hereby waived pursuant to Section 5-173(c)(4) of the Code of the City of Sunrise, Florida.

Section 3. The Procurement Manager is hereby authorized to execute the Agreement and to take all necessary action for the full performance of the Agreement.

Section 4. The Procurement Manager or designee is hereby authorized to renew, amend or extend the Agreement when renewed, amended or extended by the lead agency.

Section 5. Effective Date. This Resolution shall be effective immediately upon its passage.
